



Boulder County's Dental Aid, Inc. Receives \$40,000 through Denver Post Season to Share.

Grant to be used to provide dental care to uninsured children.

LAFAYETTE, Colo., September 5, 2017 - Dental Aid, Inc. announced it has received a \$40,000 grant from Denver Post Season to Share, a McCormick Foundation Fund. Dental Aid will use the grant to provide oral healthcare to Boulder and Broomfield counties' uninsured children who have significant oral healthcare needs.

In all, \$2,300,000 was distributed to 51 nonprofit organizations across the Denver metropolitan region through Denver Post Season to Share in this grant cycle.

“We are truly grateful for the grant from The Denver Post Season to Share,” said Dennis Lewis, Dental Aid, Inc.’s CEO and president. “The need for oral healthcare services among Boulder and Broomfield’s uninsured children is tremendous, and this grant will enable us to support some of the most serious cases which require hospital resources to deliver restorative dental care.”

About Dental Aid

Dental Aid provides compassionate, affordable, high quality dental care and education to low-income and uninsured residents of Colorado’s Boulder and Broomfield counties.

The long term clinical focus of Dental Aid follows a chronic disease management model directed at prevention, education and treatment in the early stages of disease. In addition to direct clinical care, Dental Aid prioritizes education and outreach to high-risk patients including:

- Families and children of all ages
- Pregnant women
- People with chronic diseases such as diabetes, heart disease and HIV/AIDS
- People with physical, mental or emotional disabilities

Dental Aid was one of the first stand-alone, nonprofit, complete-care dental clinics in the U.S. The organization was founded in 1974 as a referral organization and opened its first full-service clinic in 1980. Today, Dental Aid provides dental care to more than 8,000 children and adults annually. It provides services through three clinics (Boulder, Longmont and Louisville, CO) and a satellite clinic at the Boulder Shelter for the Homeless.
